



Solidarity-Based Content Sharing on SocialMedia: A Closer Look at the Language Style among Millennial Social Platform Users

Abstract

Social Media platforms have shaped diverse linguistic issues through informal language use, language adaptation and change, linguistic creativity and global communication. The current study reveals the issues about investigating about language style and linguistic form of solidarity expression used by the millennial community on social media platforms. Thirty respondents who aged about 23-43 years old considered as millennial participated in this study and inquired through open-ended questionnaire. The data was probed by using grounded theory proposed by Creswell. The findings exposed that language style were realized for certain communication purposes and based-social context oriented, solidarity expression was shown through a different linguistic form to reveal ideas, feeling, empathy, caring, respect, moral justice and kinds of arguments. after deeply investigated, there were four types of language styles that are dominantly used by millennial on this social media platform, namely formal language style, informal language style, slang language style and colloquial language style, unfortunately, many people abuse social media as a platform for venting their anger and their disappointment by using disrespectful language and behaviors are frequently observed online. Consequently, this scholarly paper also provides advice on the user of social media platform must possess a range of skills including linguistic knowledge, sociocultural knowledge, and the ability to use language in appropriate ways depending on the specific communicative context.

Introduction

Recently, technology is evolving quickly and changing many aspects of human life. the change is clearly seen like communication technologies that have increased the possibilities for how people can send and receive information. Social media is one of the most powerful sources for information and news updates (Esteron, 2021). It is as a network media which has the power to shape public opinion and influence behavior. They can amplify messages, create

trends, and drive social change. Social media platforms facilitate the dissemination of information, facilitate communication of individual perspectives, and facilitate the achievement of collective agreement on matters of action (Castells, 2012; Ekström and Stman, 2013; McGarty et al., 2014). Social media Users build and preserve relationships with other people who have similar needs, interests, or issues while also sharing their ideas, insights, information, and other content (Cho et al, 2010).

Social media presents a platform for all users to freely express themselves through various form of linguistics style (W. Yin and A. Zubiaga, 2020). Freedom of self-expression is a fundamental principle of social media, as these platforms provide an outlet for users to post their views on a wide range of topics, including politics, social issues, solidarity, entertainment, hobbies, and personal experiences without facing direct censorship or restrictions from the platform itself. There are cases of language use are not rare and can severely impact user experience and even the civility of a community such as offensive language and abuse language (C. Nobata,2016). In consequence, there are so many languages which people should take care of what they can write in giving their content sharing. Language comes in different variants that are determined by area, age, career, or social status (Alozie, 2019; Ampera et al., 2020).

The content shared on social media is constantly evolving, providing current events, trends, and various information. The types of content found on social media are Text Posts, Image, Videos, Meme, Links, advertisements and etc. A content has various positive and negative responses expressed through various language styles. Language style is the preferred method of utilizing language (Ducrot and Todorov (1993; Natsie et al., 2022). It relates to the way multiple expressions are utilized to convey the same information and is related to distinct varieties of language that are employed in different circumstance and context.

The presents study explores investigating about language style and linguistic form of solidarity expression used by the millennial community on social media platforms. Millennials are those who were born between 1980 and 2000 and grew up in the Internet digital development (Kaifi,2012). The content of Abby Choi's murder as the source of this study. In the murder cases, there are a lot of reactions such as: judging the killer, praying for the victim, complaining to the justice and expressing their emotions.

Literature Review

1. Language Style

Language is an important in the construction of a social media content. It constitutes acts of identity via ideologically constructed relations between language style and social meaning (Eckert, 2008; Zhang, 2005). Language serves as a primary medium for communication, and the act of communication typically occurs within a certain social framework. The necessity for good communication is in the comprehension and acknowledgment of the interrelationships existing between a language and its users (Amberg, 2009; Muvid et al., 2023). Language serves as a means of expressing not just our personal ideas, but also the societal values and customs prevalent within our family-related, social, and communal associations Language style.

Language style is the manner in which people communicate using language, whether it could be oral or written Chaika (1982). Language style refers to the selection of linguistic structures employed to communicate social or visual intentions. Every single person has a different language style, which is influenced by various factors including cultural background, level of education, social status, personal experience and various social context. Each language has its own set of stylistic conventions and norms. Additionally, the use of language style can also serve as a means of identity or group affiliation. For instance, certain communities may have their own distinct language styles that help express their shared values and cultural identity.

Kirszner and Mandell (2003) identified four distinct language styles, namely formal, informal, slang, and colloquial. These categories align with Joos' (1967: 11) classifications of frozen, formal, casual, intimate, and consultative styles. In this instance, the scholar conducts a comparative analysis of the language style theory proposed by Krizner and Mandell (2003) and Joos (1967). The function of language is how people use their native tongue when they speak more than one (Halliday, Chaer and Agustina, 2004). It implies that language serves as a tool for human interaction and communication. The author of this study applies Halliday's theory of the use of language to examine how millennials utilize language in different contexts. According to Halliday, there are seven functions of language listed in Howard Jackson's book (2011) which are instrumental, regulatory, representational, personal, heuristic, imaginative and interactional.

2. Social Media Content Sharing

The increasing prevalence of social media platforms has brought about a range of concerns over the scope of their utilization and the nature of the information being conveyed (Bashir, 2021; Supsiloani et al., 2022). Social media are Internet-based services that enable users to interact, collaborate, and create, share, and find content (Kim, 2010). One of the most appealing aspects of social media is the facilitation of user-generated content, which has the potential to transform individuals from passive content consumers to active content creators (Nov et al., 2010; Purba et al., 2018). Social media blurs the traditional line between media and public by giving people places to talk to each other and take part, this changes the role of the user from receiver to creator (Kim et al., 2010; Lee, 2012; Amal et al., 2022). It also differs from traditional media in that it allows for real-time two-way communication from many to many with no external control (Chen et al., 2018; Ingtias et al., 2022). It offers global connectivity that encourages social interaction, contribution, and participation via posts, comments, reviews, and feedback (Bashir, 2021; Safrizal et al., 2022) which is Social platforms like Facebook, Twitter, Tiktok and YouTube are changing how people consume and distribute news.

3. Solidarity Sharing

Solidarity plays a major role in the freedom of conscience and individual rights, moral pluralism, moral education (empathy, caring and respect), moral justice (fairness) and political community; and the argument of religion and solidarity can give significant support in the cultural resources against the global trends that threaten the environment. Solidarity as “a shared consciousness, experience, history, or identity (Prainsack & Buyx, 2011; Ingtias et al., 2021). There are some commonalities among these definition about solidarity. Firstly,

solidarity is socially based; that is, solidarity exists as a result of the existence and the interactions with the other within a given context. Second, solidarity is a result of an intentional and conscious decision. Individuals, groups, or communities consciously decide to build some form of solidarity among them or with another individual, group, or community, due to specific reasons in a given context. Third, solidarity is a reciprocal attachment or commitment people consciously have to each other based on selected similarities or interests.

Undeniably, solidarity first and foremost requires specific types of behavior or action, such as support and help. Yet, the role of emotions and attitude is essential in building and strengthening solidarity. This rejection might be a result of how solidarity has been approached. That is, solidarity has never been considered as an extra-linguistic event; hence, abstract aspects, such as emotions and attitudes that are expressed linguistically, have never been examined in relation to solidarity. Indisputably, solidarity, as a communicative event, and its expressions can take on a variety of linguistic manifestations. In the available literature, there are a few attempts to scrutinize solidarity and its verbal expressions. Honohan (2008), for example, examined metaphors in political discourse to show how metaphors can construct or facilitate solidarity, concluding that some metaphors did play a pivotal role in building political solidarity

Finally, solidarity is primarily displayed through actions. Part of this action, we argue here, is how individuals and groups communicate and interact in any given social and interpersonal context. Hence, solidarity is also communicative; that is, from a linguistic perspective, solidarity is achieved and reproduced through language. To stretch it, we can argue, more often than not, that solidarity starts and is achieved first through language and then actions. Larry May (1996). May (1996) argues that solidarity consists of the following elements: 1) conscious identification with the group, 2) bonds of sentiment, 3) common interests in the group's well-being, 4) shared values and beliefs, and 5) readiness to show moral support. These elements, as Alharbi (2018) argues, need to be expressed and communicated verbally, an aspect that has not been studied extensively. Hence, Alharbi (2018) suggests another two senses through which solidarity can be viewed and examined, i.e., discursive and performative. Viewing solidarity from a discursive lens allows us to have a clearer understanding of how solidarity is constructed in discourse, and consequently, develop a comprehensive theory revealing relevant strategies and tools.

Research Method

In qualitative descriptive research, researcher prioritizes comprehending the distinct context of the particular human experience. This style of investigation necessitates adaptable research methodologies that are inductive and dynamic, while ensuring that the data remains faithful to the phenomenon under examination (Ormston et al., 2014; Sandelwoski 2010). This study aims to examine the language style and its function in the written responses to the phenomenon surrounding the murder of Abby Choi on the Instagram social network within the millennial generation. This research explains the social phenomena which is how millennial users of social media could share their solidarity reaction based on some moment. According to Hsieh Shannon (2005), qualitative content analysis has the potential to effectively analyze various forms of communication resources, including social media.

The data in this research is using questionnaire where millennial social media users' expressed their solidarity to content sharing about the murder of Abby Choi in Instagram via link <https://www.instagram.com/reel/CpKtD-8P7qv/?igshid=MzRIODBiNWFIZA>. Open-ended free-text replies in questionnaires have been recognized as valuable data sources in qualitative descriptive studies (Kim et al., 2017; Purba et al., 2019). Specifically, the utilization of online open-ended questions has the advantage of reaching a wide geographical audience (Seixas et al., 2018; Amin et al., 2021).

In order to characterize, clarify, and draw conclusions about the phenomena of the study object from the sample data that has been gathered, descriptive analysis is utilized. The theory proposed by Miles (2014) posits that the evaluation of data involves three distinct processes: data reduction where the researcher selected the answers from the questionnaire, data display where the data are categorizing and organizing into the table, and conclusion drawing or verification where the researcher analyze the solidarity expression from the answers first, then analyze the language style and language functions from millennials expressions.

Results and Discussion

Result

This chapter provides a comprehensive analysis of two data categories. Expressions of solidarity and a certain linguistic style are present. The questionnaire was completed by a total of 35 participants. The research data primarily examines the manner in which news about Abby Choi's murder is conveyed on Instagram. The questionnaires were analysed using grounded theory to uncover patterns of solidarity expression and linguistic style. The data provided is succinct and presented in the following manner:

Discussion

The data of table 2 which are collecting from 35 respondents, but there are 30 respondents which are eligible as the Millennials. The data of table 3 which are collected from 35 respondents, there are various functions of language style. The researcher found 5 functions of language which are 2 regulatory, 6 representational, 14 personal, 2 heuristic, and 6 imaginative functions of language to the content sharing of Abby Choi's murdered. The detail

analysis of the results made as clear explanation why the expressions are belonging to solidarity expression and why their expressions are called as one language style and language function.

Solidarity expressions are found in all reaction or answers from people who filled the questionnaire because they share their empathy, their moral values such as moral injustice, moral education, moral pluralism, caring and respect to the case murder of AbbyChoi who was killed tragically by her ex husband. There are 4 from 7 language style which are found from the expressions which are formal (it can be seen when people expressed their thought seriously, using standard form of language, no abbreviations and using modal such as must, might, could, should), informal (the language style is considered as informal when people use the casual words, the sentence is less on grammar, using acronyms and lacking a clear subject or verb), slang (it can be looked as the people's language where people use idioms to share that language), then colloquial (it used incorporates constructions and shorter versions of words).

The research found 5 from 7 language functions in millennials expression which are regulatory (this functions use language to begging, rejecting suggesting, organizing and approving among others), representational (this function is used when people express ideas or convey information), personal (it is used when people convey thoughts, feelings and other deeply felt reaction in a person), heuristic (it is used to represent the questions from people), then imaginative (it is used to convey feelings, fantasies, and thought, whether or not they are true.

Conclusion

The research conclusion shows that the function of language in the millennial generation may use a personal function that reveals how they think about the function of language when the millennial generation conveys their responses in their language style. Millennials love conveying thoughts, feelings, and other deep reactions to someone. With a total of 14 personal functions of language style data written by the millennial generation in solidarity content about Abby Choi. The conclusion is simply that the language used to show expressions of solidarity can represent various types of language styles and language functions of the millennial generation who express their thoughts, ideas and feelings in one sharing content Instagram.
